She is working on a project to test 10 different products being sold within the city. ● Tru Narc Project: MADC received funding from Office of Drug Policy that went to a Tru Narc for the Meridian Police Department. See video on what Tru Narc is. This is a great tool for Meridian Police Officers to detect what type of drug is being concealed without being exposed to it. Thank you Idaho Office of Drug Policy. ● Drug Free Idaho and West Ada School District hosted a vape education night presented by Lynn Reimer of Act On Drugs. A few facts that were presented are on the attached handout. ● Homework for MADC members: On your own time please watch Seattle is Dying. If you feel like it can be integrated into the work that MADC does please send that feedback to Kendall. ● ID Prevention and Support Conference in Sun Valley was last week. ● ICAAD Conference: Annual Prevention Award went to Sharlene Johnson. Sharlene has been contributing to substance abuse prevention efforts in Idaho for over a decade. She founded and served as the President of the Kamiah Community Partners Coalition, worked as a Grant Director for the Office of Drug Policy, and currently serves as the Executive Director of the Upriver Youth Leadership Council. Through her position with UYLC Sharlene directs lunch and learns to educate local healthcare workers, law enforcement, and the public. ● Spring Safety Flings: In conjunction with National Prevention Week, MADC participates in the annual Spring Safety Flings in all Meridian middle schools. Thank you to those volunteering for these events. ● DEA RX Take Back: Took in 812 pounds / 21 boxes from 350 cars. This was a successful event, partnering with BBB and Crime Stoppers.

Two breakout sessions are focusing on drug prevention 1) Substance Abuse Prevention in your community and state resources for rural areas. 2) Panel along with a viewing of Chronic State: Kendall is working with a member of Governor Otter's team to be part of the panel. If you have suggestions for someone to speak on this panel please let Kendall know. Deadline past. • Mary: All day brainstorming session with Health Care Advocates across Treasure Valley on the regulation of e-cigarettes products. Within the discussion they identified some short term goals to help address the issues within Idaho: Comprehensive Analysis of license for e-cigarettes.... What is written in code, fees, and what should the definitions be while passing regulation on e-cigarettes. This group is looking for more partners to be part of this process. Actions will start to take place this summer regarding education for legislators. We are the fifth lowest in the nation in terms of tobacco tax. If we increase tobacco tax by 1.50 per pack it would equate to 58.97 million. This would also decrease youth smoking by 16.5. • Nicole: Idaho Conference on Alcohol and Dependency 35th annual conference held at BSU this week: Five focuses this year: 1) Prevention 2) recovery and support 3) youth and family 4) clinical skills 5) criminal justice. Overall great conference.
